A Day At Daytona

Our day at Daytona International Speedway began early approximately at 9:30am. We had a package deal that transported us from the hotel to the track, access to the track and Fan zone area, plus a cute cooler filled with goodies.

It took the bus approximately 20 minutes to actually get into the parking lot. The lot began filling up at 9:30am however the race didn't start until 2:30pm! The usual line up of food vendors filled the grounds alongside the drivers' trucks with all their gear.

Finally, after getting inside to our fourth row back seats the race began, with a late start of about 3pm. The pride of the military planes flying overhead in specular unison was awesome. Roaring back and forth with a defying speed of sound. After a pretty smooth run on the 2.5-mile track, early on we yielded to three restarts with a few major drivers like Bubba Wallace and Jimmy Johnson losing ground early in the race. The race finally ended after two extensions of the 212 laps race and approximately four crashes, halting the race a few times. My dude Bubba Wallace came in at 20th place and Ricky Stenhouse Jr. took 1st place.

However, the real highlight of my trip was the ride along on Monday at the track. This experience was by far the most exhilarating ride of my entire life. I've done ride alongs before at New Jersey tracks but this one was far more superior.

The excitement of seeing and hearing these cars roar around the track, knowing my turn was coming was overwhelmingly exciting. Each of was given a number as they called us up by tens. We were given number 84 & 85. Finally, our turn came to slide through the

window feet first and be strapped in.

We took off on our three-lapse speed journey slow but accelerated quickly. Our car grabbed the curves at top speed like Jimmy Johnson was on our tail! The sound of that car plowing through the straight away was like a bat outta hell. My driver hung on to the

curves like a pro driver, as I screamed with excitement and cheered my driver on every inch of the way. Hearing the sound of those massive engines soaring around the track was sheer joy. I was in racetrack heaven. The intensity of the g-force was so extreme that lifting my cell phone from my lap to take a picture was a major struggle.

When the last lap came to an end, and they pulled me out of the car window, I could barely contain my joy. Feeling so pumped up I asked the guy who helped me out of the car how fast he thought

we were going. He explained that my driver was his son, who has a good driving record and we were probably going from 155-160 miles per hour! WHAT! That added to my excitement and my immediate decision to do this again very soon.

Walking away from the track, I knew others would share my excitement and this experience was by far the highlight of my trip to the Daytona International Speedway.

At the April general meeting 2023 the ballots will be handed out to members in good standing who have accumulated enough active points and have paid their dues to vote.

PROPOSED CHANGES TO THE LICOA BY-LAWS - SEPTEMBER. 2022

Each Of The Proposed Amendments To The By-Laws Require A Separate Yes Or No Vote.

All BY-LAW CHANGES SHALL GO INTO EFFECT THIRTY (30) DAYS AFTER ADOPTION THEREOF BY THE MEMBERSHIP.

- **Art. 1** (3) ADD: The President and Treasurer only, shall be provided with a key to the LICOA P.O. Box (#191) in the East Meadow, NY Post Office.
- Art. II (1) ADD: Lifetime members (25 years of membership, or more) shall be exempt from the requirement of owning, leasing or otherwise having access to the use of a Corvette.
- Art. II, (5.) (a) (1.) At end of the existing section, add the following: "All active members with ten {10} or more years LICOA membership, who moves out of New York State, but continues to pay annual membership dues and attends four (4) events or ZOOM Meetings per year shall remain eligible to vote in all LICOA elections held for any purpose.
- Art. II (5.) (e)(2). Change section to read: "All Lifetime Members who attend four (4) events and/or ZOOM Meetings per year shall retain their Life Member status and shall be eligible to vote in all LICOA elections held for any purpose.
- Art. II, (6 a) Membership fees to be amended as follows: New member annual dues: \$60.00; Member annual renewal dues: \$50.00; Member joining LICOA on or after August 1, dues for remainder of year: \$40.00.
- Art. II, Sec. (7 b) ADD: Sec. (b4) Payment of LICOA annual dues shall be suspended for any LICOA member who is on Active Duty with the US Military.
- Art. II, (Sa) Change paragraph one of this section to read "An active member (active member as defined by the LICOA by-laws) shall have the right to petition for the termination of membership of any member or members who have displayed conduct detrimental to the furtherance of the goals and purposes of LICOA, or conduct which subverts the legitimate purposes or day to day operations of LICOA, including commission of any acts of moral turpitude."
- Art. 11, (10 b) Change "21" to "18" in two places; ADD: 'or under age 18 and holding a valid NYS Driver's License".
- Art. IV, (3 b) This section shall be amended to apply to all present members of the Board of Directors.
- Art. IV, (5) Amend to: "In order to run for a position on the LICOA Board of Directors, a candidate/ nominee must be a member in good standing of LICOA for a minimum of two (2) years before his/her nomination."
- Art. IV, (6 a) Eliminate existing provision and replace with "Any elected member of the Board of Directors, including all members of the Board presently holding office, may run for re-election after his/her two (2) year term has ended and, hereafter, there shall be no term limits for any member of the Board of Directors.
- Art. IV, (7 e) Eliminate existing provision and substitute: "Any elected Board alternate who replaces another alternate, or voting member of the Board, shall be permitted to run for any Board position in the next (upcoming) Board of Directors election.

Art. V, (4 I) to be amended as follows: ADD: Any LICOA expenditure of \$250.00., or less, may be approved by the Board of Directors. Any LICOA expenditure over the sum of \$250.00 shall be approved by a vote of the membership present at a meeting where authorization is sought for the expenditure.

Art. V, (4 o) All reimbursements made under this section shall be made by LICOA check(s) only.

Art. VI, (1 a) Eliminate existing section 1 a, and amend as follows: "Appointment to any of these positions shall be approved by a majority vote of the Board of Directors."

Art. VI (2 a) This section (2 a) to be eliminated.

Art. X, (7) The point system for event credits shall be eliminated for "Member of the Year" and "New Member of the Year". The winners of these awards shall be determined by a majority vote of the Board of Directors.

Art. X, 8 (b) ADD: No member of the Board of Directors shall be eligible for the Member of the Year award.

Art. XII, ADD: to title of Article: "(applicable to Officers of LICOA, only)."

NEW ARTICLE XIII -TO BE ENTITLED "CAMPAIGNING FOR OFFICE BY CANDIDATES FOR THE BOARD OF DIRECTORS."

Sec. 1 (a) No candidate for the LICOA Board of Directors shall: 1) Place a paid, or unpaid campaign advertisement in the LICOA Courier. 2. No candidate shall campaign at any LICOA event, or monthly general/special, or Board of Directors meeting. "Campaign" shall be defined as distributing campaign literature, buttons or bumper stickers, or leaving campaign literature, or other campaign tokens, on car windshields at LICOA shows or events, or making campaign speeches at any LICOA show, event, or meeting of any kind.

Sec. 2 (a) The Courier Editor shall not accept for placement, or create for inclusion in the Courier, any of the following: A) an advertisement in favor of, or against any candidate for a position on the LICOA Board of Directors; B) An editorial in favor of, or against the candidacy of any member seeking a position on the LICOA Board of Directors, or C) Make any recommendation for or against the election of any candidate for the LICOA Board of Directors in any edition of the Courier, at any time during a calendar year. A violation of the provisions of A, B, or C, above by the Courier Editor, shall be grounds for removal of him/her from the position of Courier Editor.

ADDITIONAL CHANGES TO LICOA BY LAWS

Art. IV 6(a) Change to read: Eliminate existing provision and replace with "Any elected member of the Board of Directors may run for re-election after his/her 2-year term has ended, including any elected member of the Board of Directors presently in office, and, hereafter, there shall be no term limits for any elected member of the Board of Directors. 11

ADD: Section 3, Art. II: at end of first paragraph, the following: "However, any member in good standing who moves out of New York State, who has been a member of LICOA for ten (10) years or more who continues to pay dues and attends four (4) events or ZOOM Meetings per year, shall be eligible to vote in any and all LICOA elections. 11

ADD: Art. II, Sec. 5 (e)(2) change existing provision to read: Life Time Member who attends four (4) events per year and/or four (4) ZOOM meetings per year shall be eligible to vote in any and all LICOA elections."

CHANGE TO CURRENT BY LAWS OF LICOA REGARDING APPOINTMENT OR ASSIGNMENT" As per the BYLAWS OF LICOA the following Reference is made: Article IV Board of Directors (Page 9)

Section 1. The affairs, business and property of LICOA, shall be the responsibility of the Board of directors, EXCEPT for those duties conferred on the Officers by-law, or the Articles of Incorporation or the By-Laws of LICOA.

Section 4. (Page 10)

To assist in performing their duties; the Board of Directors MAY appoint any Special Officials or Special Committee, to Serve, Assist, Advise, or Inform it may confer thereon such powers and authorities as it may deemed Advisable and Necessary.

4A. The Board of Directors shall appoint the following Position(s) from Active members:

Competition Director

Show Coordinator
